Beginning on August 2, 2019, and in light of SCTA ders'continued refusal to begin negotiations with the District, and/or SCTA leaders nditioning negotiations on resolution of other items as evidenced in various letters from SCTA to the District, the District began presenting its proposals for bargaining electronically. Between August 2, 2019 and December 9, 2019, the District submitted to SCTA leaders all of its proposals on the articles of the CBA that the District had sunshined in November 2018. Each proposal presented to SCTA leaders showed the changes that the District proposed to make to that article by using strike out affided text.
